

Property Participation Agreement

This Property Participation Agreement is effective from the day the property listing is made active and continues until the anniversary of the effective date and sets forth the terms & conditions under which the property agrees to market its property.

Fee: The fee publicized for a Crew Break Listing is applicable for a single property only. Once we receive your property listing(s) details and payment, we will email you a receipt and notify you that your Crew Breaks listing program has been placed online.

Booking Procedure: Crewconnected.com is not a booking service it is purely an information service, which allows our members to make a booking enquiry to the listed property'. All booking procedures, reservations, and other offerings made through Crewconnected.com are solely between the prospect customer and the property concerned. Property shall book rooms for guests through the booking enquiry system according to their current operating procedures.

Correspondence: A reply to the incoming booking enquiry should be made at the properties earliest convenience. Upon delivery of a booking enquiry (electronic message) property must honour the request and reply with a reservation confirmation or if no rooms are available, a reply to that effect.

Operational Details: At any time property may change all aspects of their Crew Breaks listing. Property may change the text, photos, rates, rooms, number or types of rooms at any time. Password protected access to each listings' administration area is provided, allowing the property to adjust all aspects of their listing 24 hours a day. Crewconnected.com representatives are also at hand to provide any assistance that may be required.

Rates: Property shall set the rates for rooms according to their current availability and discretion. Two sets of rates are required for each room type namely: Normal Rate and Crew rate. The Normal rate is the same rate offered to the general public. The Crew Rate must at least comply with travel industry rates and be less than the normal rate. Crewconnected.com does not change property rates once they have been uploaded initially and verified by property. Any rates which are deemed "wrong" to the property are the sole responsibility to the property,

Availability: All offers are based on availability. The property has no obligation to confer to the request of any specific booking enquiry and has the right to limit quotas.

Identification: Presentation of an Airline ID card, an IATA card, or a letter from the Company on letter-headed paper is required at all times when travelling to present to the property upon arrival and unless as allowed by the property.
